Approximately three years ago when universities across the country were grappling with the ramifications of student demonstrations, the students within the Department of Urban and Regional Planning, realizing the need for meaningful student input into departmental decision-making, organized the Student Planning Organization. Initially the organization's fundamental goal was to gain equal representation on various faculty committees. Presently planning students are well represented on such standing committees as Admissions, Research, Faculty Recruitment, and Curriculum. With student participation on these committees priority setting and issue development have been facilitated. The Student Planning Organization has been instrumental in publishing a departmental newspaper entitled "Spark" which is serving as a communicative mechanism for students and faculty. The format of "Spark" is not limited to planning concerns, but rather is open to a broad range of ideas and opinions. The Student Planning Organization is also concerned with increasing the social interaction between graduate and undergraduate students. To this end a department softball and volleyball team have been organized with the motto, "it's not important whether you win or lose, but rather how you play the game that counts." Picnics have also been planned with the intention of involving students with the faculty.

I would like to see the Student Planning Organization develop into the kind of on-going organization that would serve a variety of planning student needs. Besides representing student interests, the Student Planning Organization can be the medium by which students relate meaningfully to each other.
