

# Department Year In Review

The Department continued to experience growth during the 1974-75 academic year. As of the spring semester there were 86 students in the B.U.P. program (compared with 74 in 1973-74) and 61 studying for the M.U.P. degree (an increase of 10 over the previous year). The 39 students who entered the graduate program in August of 1974 were selected from 190 applicants. The Graduate College has placed a ceiling of 70 students on the Department's graduate program, so our aim henceforth will be to admit 35 new students to the program each year.

The graduate students who entered in August were the first group to operate under the new program, described in this space a year ago, wherein the list of required courses has been replaced by a set of required categories of courses, thereby giving each student a greater range of choice in developing his or her individual program. Thus far this approach appears to be working quite well, and the level of student satisfaction with the program was much higher than at any other time in recent years.

The second-year class was also the first group to be faced with the requirement of undertaking either a Master's Thesis or a comparably-ambitious Major Project in lieu of the thesis. (All chose the latter option, incidentally.) A number of interesting studies were carried out. One unforeseen problem did occur, however: many students badly underestimated the time needed to carry out a Major Project; nearly half of those in the class were unable to finish their projects in time for May graduation, and will graduate in August instead. With tighter control of deadlines, we hope to avoid this situation next year.

Revisions in the B.U.P. program (also described here last year) are still being considered in the University's approval hierarchy, and it appears that the new, more flexible requirements will go into effect in the fall of 1976.

Plans continue to be made for the introduction of a Ph.D. program in Public Policy Analysis and Planning, although progress in obtaining the necessary cooperation and approvals from other units on the campus has been frustratingly slow. We will eventually have a doctoral program, but it still appears to be at least two years from becoming operational.

Recognizing that the best-designed curriculum in the world can still go sour if the quality of instruction is deficient, the faculty this year undertook a process of self-study. With the cooperation of the University's Office of Instructional Resources, a series of seven faculty seminars was conducted on the issue of student performance evaluation. We plan to continue these efforts next year, with emphasis on such matters as effective seminar management, student-teacher interaction, etc.

A vigorous process of faculty recruitment was recently completed with the hiring of Dr. Michael Romanos, currently on the planning faculty at Cornell. Dr. Romanos will join us in August, and will assume responsibility for the massive UP 171 (taken by some 450 students annually) as well as offering courses in transportation and land-use planning.

The sole departure from the faculty at the end of the year is Sarah Boros, M.U.P. '74, who capably handled UP 171 and other courses on a one-year basis.

Faculty members on sabbatical during the year were Lou Wetmore and Clyde Forrest in the fall, and Eric Freund in the spring. Eric will extend his sabbatical through the 1975 fall semester, in order to complete his research on social program development in British new towns. Ade Onibokun took a leave-of-absence for the spring semester in order to assist in the development of a new planning program in Nigeria, and has extended his leave through the 1975-76 year. Carl Patton continued to be on leave in order to work on his Ph.D. in the Graduate School of Public Policy at Berkeley; he returns to Illinois in the fall.

On the other side of the coin, Eugene Kirchherr, Professor of Geography at Western Michigan University, took sabbatical leave from that institution during the spring semester and spent it with us. Gene made a number of contributions to our program, both formally and informally, while he was here.

The volume of research being conducted by the Department's faculty continues to grow rapidly; grants were received during the year by Lock Blair, Bill Goodman, Len Heumann, and Andy Isserman. John Quinn, meanwhile, has assumed responsibility for the development of a much-enhanced program of continuing education, aimed primarily at professional planners in the state and region. Many of you will be hearing more about this later.

Under the leadership of Al Guttenberg, the Bureau's publication program was revised significantly during the year. The Bureau Newsletter was replaced by a new quarterly periodical, Planning and Public Policy. A series of "working papers" is being developed under Andy Isserman's editorship, and the Bureau's mailing list is currently undergoing an extensive overhaul.

Two gifts were recently made to the Department by alumni. Wendy Singer, M.U.P. '73, donated an easel for use by students, noting that there had never been one available when she was expected to make a presentation during her own student days. And Vernon George, B.S.C.P. '61, made a much-appreciated cash gift to the Department. We are deeply grateful to both Wendy and Vern.

These gifts have stimulated some discussion here concerning ways in which the program's alumni might be involved more actively in the ongoing life of the Department. At present we have no Departmental alumni association, nor have we sought funds from alumni--despite the University's extremely tight budget situation, the virtual disappearance of outside fellowships and other sources of financial aid, etc. We do not have an Alumni Advisory Committee, nor any other formalized mechanism for obtaining alumni input on the major decisions on curriculum, degree requirements, faculty development, etc., which are made annually.

Should we have some or all of these things? I would like to hear from you on these matters. If you have an opinion, or any additional suggestions for alumni involvement, please drop me a line.

Finally, let me express my gratitude to those who have helped in the preparation of this newsletter: Mike McDonough, Barbara Hartman, Eleanor Penn, Jane Terry, and Linda Ely.

# Faculty News



## Lachlan F. Blair

The highlight of my year was the performance of five teams of students in my Environmental Planning Workshop during the fall semester. Historic Preservation studies were done for Monticello, Decatur, Lincoln, and Logan County, as well as a downtown plan for Effingham. Handsome professional-quality reports were published (most of them at local expense), and the support of the communities was most gratifying. Members of the teams have had recognition from community groups for their service and in most cases there is quite encouraging local follow-up on their recommendations. All of this is bonus on top of the realistic learning experience in dealing with local officials and citizens. The spring semester workshop is dealing with DeWitt County, with studies ranging from historic preservation to the impact of a nuclear power plant.

I continue to be much involved in statewide preservation activities, and have been working with several colleagues in other departments to arrange conferences on Preservation in the Midwest here next fall and for the summer of 1976. My current research projects include a study of the social impact of a dam and reservoir, and one on techniques for identifying and ranking water and related land-resource problems in the Upper Mississippi Basin, being done jointly with three other state universities.

I have been filling a few evenings with activities as Chairman of the Urbana Plan Commission and member of the Champaign County Regional Planning Commission.

On the personal side, we became proud grandparents last August of Jonathan MacDouglas Blair, son of Douglas MacLachlan Blair, in Bloomington, Illinois. Our daughter, Marilyn, continues her studies in Geology at Beloit College, which she expects to finish next year.

## Michael P. Brooks

At the end of the spring semester, I will have been on the Illinois staff for four years. There are days when it seems only yesterday that I arrived--and other days when I think I've been here forever! In any event, I have by now become thoroughly acclimated to the Illinois environment, as best evidenced by the fact that I no longer make obnoxious comments to my colleagues about "the way we did it at North Carolina." (In fact, I am now convinced that the way we do it at Illinois is vastly superior!)

I continue to teach one course each semester, "Planning Strategies and Models" (an "applied" planning theory course) in the fall and "Introduction to Social Planning" in the spring. Enrollment in the latter increased from four students in 1974 to sixteen in 1975, encouraging me to feel that student interest in social planning has not disappeared after all.

Committee meetings continue to absorb a ridiculous proportion of my time. During the year I ended my stint as Vice-Chairman of the Board of Directors of the Champaign County Development Council--but was elected to the Board of

the Levis Faculty Center, in which capacity I worry about the cuisine and recreational activities of the Center's 1200 members. How's that for an exercise in social planning?

My travel for the year consisted of lecture trips to the University of Wisconsin - Milwaukee, Iowa State University, and Oakland, California (the League of California Cities), as well as attendance at the AIP (Denver) and ASPO (Vancouver) Conferences.

I was recently elected to AIP's National Education Development Committee, the body which will be responsible for implementing AIP's planning school recognition procedures. (It will be highly embarrassing if I find myself aiding in the formulation of policies which result in de-recognition of the Illinois program! Don't worry--it won't happen.) My first assignment consisted of a visit to the University of Utah to review that institution's plans for a new planning program.

Two years ago the Association of Collegiate Schools of Planning issued a Guide to Graduate Education in Urban and Regional Planning. It was, in my opinion, a pretty bad job, and I voiced my opinion to ACSP's offices. The result: a grant to the University of Illinois from ACSP, under which we will have responsibility for preparing the next edition. That will teach me to open my big mouth!

I hope to see many of you in San Antonio, where we will assuredly have some sort of alumni bash.

#### Clyde W. Forrest

I greatly enjoyed my first sabbatical during the Summer and Fall of 1974. I and my family traveled in Europe for three and one-half months in a VW Camper. The topic of my study was the national planning structures of The Netherlands, England, Yugoslavia, and Romania. The final phase was spent in the U. N. Library at Geneva supplementing the materials and interviews collected in the field. As research conclusions, I am willing to state:

1. "There is a direct relationship between spatial adequacy and domestic tranquility;" and
2. "Land travel in Eastern Europe is not as bad as some people fear but then again it's worse than anywhere else we went."
3. "Romania and Yugoslavia offer extreme contrasts in communist planning structures that warrant additional comparative analysis."
4. "The Dutch system seems to be a marvelous example of effective government planning with social responsiveness in a high standard of living."

Returning to the Campus for Spring, 1975, I found 80 students enrolled in UP 378, which is now renamed, "Law and Planning Implementation." After mid-term exams, the enrollment stood at 69.

waned despite the downturn in new town activity in the U.S. due to lack of federal support and follow-through, coupled with the recession which has harmed all business ventures. As one aspect of the practical expression of land use and development policy - and used as such in many countries - I find the subject most interesting as it involves the synthesis of so many planning elements, and also provides a medium for the study of international comparative land use policy and control.

I am writing this message from the study of the mid-18th century cottage I have rented in Southborough, near Tunbridge Wells in Kent, England. I look out at a forest of oak and birch trees and, in the distance, at the North Downs, part of the protected greenbelt around London, covered with green grass and grazing sheep. While on sabbatical leave here I will be studying the latest ideas in land use control philosophy now being forged by the Socialist Government, and the reactions to this on the part of professional bodies, developers, and attorneys. In the short time I have been here it is already fascinating. I will also be looking at social development in the new towns and large-scale developments, which has reached a high level of expertise here.

If funds permit (inflation here is about 22% per annum as compared with the U. S. 11%!!) I will also visit the Netherlands and the Paris region (and maybe Stockholm and Finland). However, there is quite enough here to keep me busy for several years, and I return in October or November.

By the way, how do you fancy motoring here? If you want to do it, gas costs about \$1.75 per gallon (admittedly an Imperial gallon is 1/5th larger than the U. S. Gallon) and the car tax has just been increased to \$100.00 per year. Radio and television also require licences at about \$48.00 per annum. Value added tax has just been increased to 25% on radios, TV's, washers, dryers, photographic materials and other items, and \$1.20 has been added to the price of a bottle of whiskey or gin.

On the bright side, there are lots of good jobs for planners, and civil service salaries have just been increased about 26%. The planning authorities are short of planners due to a recent significant increase in the number of such authorities. Americans are welcome to apply, I understand! Should you apply and if lucky, work here? It's all a question of cost-benefit analysis, and I'm sure you are all experts at that technique - so work it out for yourselves! See you again in next year's issue!

#### William I. Goodman

During 1974-75, I continued my activities in urban transportation, working with a campus committee to formulate a proposal to establish a formal Office of Transportation Studies in the Graduate College. As this is written, the proposal has been submitted to the Dean of the Graduate College. I received a grant from the Illinois Department of Transportation to carry out a transportation workshop, and some "seed money" in connection with a project submitted to the U. S. Department of Transportation. I am also directing a research project in air quality aspects of transportation, sponsored by the Illinois Environmental Protection Agency.

In February, I was invited to participate in a colloquium on "Urban

Transportation Alternatives", sponsored by the Transportation Research Board and The Urban Mass Transportation Administration. In March, I gave a seminar at Johns Hopkins University on trans-national comparatives in urban transportation planning.

At the AIP conference in Denver, I was a panelist on the subject of education for transportation planning.

Aside from my participation in the continued development of transportation on campus, I serve on the University Press Board, on the Advisory Council to the Center for Metropolitan Planning and Studies at Johns Hopkins, and on the Committee on Energy Conservation of the Transportation Research Board.

Other items of possible interest:

- Inaugurated a new Bureau quarterly publication entitled, Planning and Public Policy (successor to the Newsletter).
- Contributed a chapter to a Textbook on Human Ecology published in January.
- Served on the teaching staff of the Center for Human Ecology of the University's Institute for Environmental Studies.
- Designed a new course for next fall on "Population and Land Settlement Policies in the U. S." The course will feature views counter to the conventional ecological wisdom.

We are all enjoying our new house. We garden, have recovered a fireplace that was bricked-in, added windows, and are planning to add an upstairs bathroom.

Andrew M. Isserman

I gained quite a bit of planning experience this semester - some of it vicariously. The forty-seven students, primarily undergraduates, in my planning analysis course prepared population estimates and projections, commercial feasibility and industrial development studies, housing and land use surveys, and preliminary community development studies for ten communities in Champaign County. They prepared final reports for the town governments and presented their results at public meetings. (If you need planners with some technical skills and experience, I am sure many of them will be glad to do your land use survey as soon as their blisters heal).

A grant from the Illinois and United States Environmental Protection Agencies was the focus of the economic analysis workshop. We tested alternative techniques for population and employment projection, recommended projection models for air quality maintenance planning, prepared reports on the locational tendencies of particularly noxious industries, and surveyed current projection practices of Illinois agencies. The grant provided research assistantships for eight students.

Scott Keyes

I don't have a great deal to add to what I reported in last year's issue of the Alumni News. I am continuing to work on the report mentioned there - Coordination and Integration of Programs Through an Areawide Advisory Budget. Unfortunately, getting a final document of acceptable quality ready to go is proving to be time-consuming, and it will be a while before we get it out.

Perhaps the most interesting development of the past year was a spring semester workshop on Bangladesh. This workshop came about pretty much through the initiative of the students participating in it, one of whom is from Bangladesh. The theme is regional development planning for developing nations. It will continue this summer and next fall. If interest continues strong, we may consider making this area of concentration a permanent part of the curriculum. One exciting possibility, if it could be worked out, would be the assignment of students as interns with United Nations missions to developing countries. Preliminary discussions with the UN indicate that this may very well be feasible, under a program called United Nations Volunteers.

Eugene C. Kirchherr (Visiting Scholar, Spring, 1975)

After a five-month period of study and research as the first Visiting Scholar in D.U.R.P., I returned to Kalamazoo at the end of May to resume my duties in the Department of Geography at Western Michigan University. I extend my best wishes to the many students with whom I shared pleasant hours in lectures and workshops.


Louis B. Wetmore



# City Planning & Landscape Architecture Library



We are happy to say that the City Planning library continues to be a center for students and faculty to gather information and exchange ideas as well as do research and write papers. Due to increasing needs for room, the slide collection has been moved to the Mumford seminar room increasing reference and reserves space. Fortunately we continue to have space for Arthur, our plant, who remains a source of pleasure to library employees and patrons as well as a surprise to visitors.

Unfortunately the library is feeling the impact of the economic situation of the university and country at large. The library book budget has remained the same while book prices have risen 50-75% in just the last two years. These circumstances have resulted in a moratorium on book orders. From March 1st of this year until July 1st, no new books are being ordered and orders for new journals have been held since January 1st. In cases where journals we already are receiving are also held by other libraries in the system we are to review our subscriptions and try to cancel ones we do not absolutely have to have on hand. This is particularly painful for our library. Planning is a dynamic, growing and changing field and needs a library with a collection that is contemporary and broad in scope as well as solid with the classics in the field. Now more than ever, gifts of reports and working papers etc., are appreciated as one method of keeping our collection current and useful.

A group was established some years ago to stimulate wider interest in and attract direct public support for the collections of the University Library. This group, the University of Illinois Library Friends, has made contributions that have been of decisive importance in strengthening the holdings of the Library. Several benefits accompany membership in the Library Friends. Occasional keepsakes, catalogs and other publications, notices of library activities, and the annual Friends publication Non Solus are sent to members, who are also entitled to a discount on the purchase of University of Illinois Press books. 

At the end of the Fall Semester S.P.O. lost its president to the Colorado employment scene. Steve Gordon was succeeded by former Treasurer Ray Ontiveros pending new elections. In the Spring an attempt was made to organize a discussion dealing with "land use responsibility". ## Women In Planning

On occasion women students have been known to remind a speaker that "he" is not an inclusive substitute for the word "planner". Planners are people - at least among the student population at the University of Illinois where 28 of the undergraduates are women and 58 are men. The graduate program has 23 women and 39 men.

In a questionnaire distributed in the middle of the Spring Semester, 1975, the women of the department were asked for their impressions of the Planning Department. Most seem to be quite satisfied with the program. In fact, several graduate students reported having been favorably impressed with the departmental policy which encourages women students to take advantage of the graduate program.

Many women did express regret over the lack of women professors in the department. Currently, only one member of the teaching staff is a woman. Although the department actively seeks women candidates for staff positions, there are certain difficulties. For example, qualified women are somewhat scarce. This is unfortunate for the present but it certainly suggests that women in the field have an excellent opportunity should they choose to include teaching among their professional goals.

In the interest of fair and comprehensive reporting, it must be admitted that one area of blatant sexism does exist in the department. Men be heartened! You too should aspire to fill new roles..... All the secretaries are women.....



DALE ROBERT SCHERER (BFALA, MSCP). "Am still with the U.S. Environmental Protection Agency in the Office of Research and Development, Ecological Impact Analysis Staff, as a Regional/Urban Planner and Landscape Architect. Work assignment relates to developing environmental indices of secondary impacts (social and economic effects on land use changes), especially as affecting the American Indian/Spanish American populations. Have developed a major research project which is looking into environmental attitudes and perceptions of these peoples and inter-relating these with the influence of mass media communication. In addition am also working on a 'wetland/recreational' development affect on environmental concerns. To keep my hand in the pot, so to speak, I am also teaching two courses at the Northern Virginia Community College - one for the sub-professional park landscape planner, and one for homeowner's who have a concern for improving their own homesites. To keep occupied during the weekend, I have a small landscape contracting firm and nursery development for black walnut trees, Christmas trees, and ornamental shrubs - mostly azaleas, hollies, and conifers for ground cover. From the way this business is growing, I might work myself out of my full time position with EPA. I don't know what the impetus is, but homeowners are beginning to take some pride in their home landscaping and our little operation seems to be able to provide the type of plant materials which they can't find at the local nursery store, supermarket, or discount house. We try to provide those plants which require little care, are ecologically suited to the locale, and don't cost an arm and leg. What we are having trouble with and which I would hope the landscape schools would stress more, is getting an individual who knows construction techniques for such items as brick walks, stone work, decks, steps, planting boxes, and the like. Local carpenters and stone/brick masons just don't have the design ability or the feeling for treating construction materials as part of the landscape. Individuals like myself can usually draw what we want, but getting skilled labor to install it is extremely difficult. From what I have seen and my own experience, professional landscape construction is practically non-existent. A good many well designed landscape plans fail because of the nonavailability of quality construction. I have found that designing a good landscape plan is relatively easy as compared to getting it constructed. Schools, such as the U of I, who have such unlimited resources in allied and ancillary courses could certainly

expand their Landscape Construction courses - such as the one that old Schaefer taught - together with courses in business practice. From my teaching experience, I have found that a goodly number of the sub-professionals have much more interest and ability in landscape construction than in design, too many "landscape architects" (recent graduates) don't want to or don't have the skill necessary to work with construction materials and in many many instances, feel that it's beneath their dignity to go out and dig holes, point sticks together or spread mulch. From my own experiences, I have had to change a lot of my "school induced" ideas and conceptions when I actually went out into the field. It is amazing how much one can learn when one is faced with translating a "paper design" into plants, lumber and stone. Enough of the lecture. I am getting somewhat ancient and find that my children, who are not children any longer, but I like to think of them as such, are leaving the "nest"; all are either in college or have graduated (4 boys and one lovely girl). Only one has developed an interest similar to my own, but he is a soil scientist and crop man - plants hold little interest. Another boy is at law school and another is an expert in international affairs (Latin America), a hotel/club manager, the oldest a Navy man (skipper of a DE), and my daughter wants to become an industrial designer. Where did I go wrong! None are married as yet, and it seems as if they never have the time or stay in one place long enough to establish a lasting relationship, but I suspect, the time will come when a family will mean more than school and working. Guess that about covers the "goings and comings" of my clan, and I look forward to the NEWSLETTER when it's published every year. I only wish more of the "grads" wrote in."







GERALD M. ROBBINS (MUP). "Working for County of Orange in California as an open space planner."


