# SCHOLARSHIP ANNOUNCEMENT FOR THE 2022-2023 ACADEMIC YEAR DEADLINE for the application: April 1, 2022

The <u>WOMEN'S ARCHITECTURAL LEAGUE FOUNDATION (WALF)</u> located in Chicago, Illinois will <u>award three scholarships with a value of \$2,000 each</u> to outstanding students of architecture who meet the following criteria and present the required documentation.

This scholarship is open to those students who are enrolled in the 2021-2022 academic year. Selection of scholarship recipients will be based on scholarship performance and financial need, with consideration given to applicant's career projections, philosophies, interests, and experiences.

Final selection of scholarship winners is determined solely by the WALF Board of Directors.

#### TO QUALIFY FOR THESE SCHOLARSHIPS, APPLICANTS MUST:

- 1) Be scheduled to graduate by June 2023, with a Masters of Architecture or a five year Bachelor's of Architecture degree from a NAAB accredited architectural program in Illinois. (Eligible Institutions: Illinois Institute of Technology, Judson University, University of Illinois at Chicago, University of Illinois at Champaign-Urbana, The School of the Art Institute of Chicago).
  - 2) Be a United States Citizen
- 3) Complete the WALF formal application

#### INFORMATION REQUIRED TO COMPLETE THE APPLICATION:

a) <u>Official grade-point average</u>, to be provided by the school, or if **GPA** is not available, send a list of classes/credits completed with current status of credits needed to graduate.

(No official transcripts required)

- b) Letter of Recommendation from a faculty member or scholastic mentor
- c) Personal statement of approximately 500 words
- **d)** <u>Current resume</u> which includes education, work history, extracurricular activities, personal interests & distinguished honors/awards
  - e) Financial statement of resources, expenses, and debt
  - f) Signature of applicant
- 4) <u>Return completed & signed application to the School of Architecture office</u> for final validation.
